



**VALENCIA HIGH SCHOOL TIGER REGIMENT BAND PROGRAM  
PARTICIPATION AGREEMENT 2010-2011**

The purpose of this contract is to establish an agreement between Valencia High School and Student's Name (Print) \_\_\_\_\_ for participation in the Tiger Regiment band program at Valencia High School.

I believe that I am the most important member of the VHS Tiger Regiment Band and that the success or failure of the band is a direct result of my *attitude, my preparation, and my personal performance* at each rehearsal and public performance.

I understand that attendance at all rehearsals and performances of the band is mandatory and I agree to be present. I agree to consult with the director for permission to be excused from or tardy to any rehearsal (i.e. make-up tests, doctor's appointment) **prior** to the rehearsal. In addition, I agree to support my absence or tardiness with a note from the teacher or doctor involved or my parent or guardian. (A parent delivering a student to rehearsal late may speak to the director in lieu of a note.)

I agree to be prompt to each event and to not have to be told to go to an assigned position. I agree to wear the proper designated clothing for rehearsal and to take care of myself following common sense (i.e. never attend rehearsal or performance on an empty stomach, drink plenty of liquids, not do rehearsal without appropriate shoes, etc.) I understand that not following these simple rules might impair my performance and ultimately hurt the band.

I agree that there may be times that I will be called on to perform or rehearse when I am not in peak condition and I will do so to the best of my ability.

I agree that the decision of the Band Director is final.

I understand that all participants (and their parents) in the band program (Marching, Concert, Symphonic, Color Guard, Winter Guard, Drumline, and Jazz Bands) at Valencia High School are members of the Valencia Instrumental Parents (VIP) band boosters. I agree to be an active member of the Valencia Instrumental Parents (VIP).

I understand that the Valencia Instrumental Parents (VIP) routinely incurs costs on my behalf and that I am jointly responsible with other active members for those costs. I agree to pay by participating in individual and group fundraisers and by paying my "fair share" pledge to the Valencia Instrumental Parents (VIP) by their due dates. The first "fair share" pledge installment for the Fall Season is \$100 due July 31; \$100 due August 31 and the remainder of \$250.00 payable in monthly installments of \$62.50 on September 30, October 31, November 30 and December 31. I understand that I will be billed on a monthly statement that reflects payments and fundraising credits. I also understand that the monthly payment could be higher or lower depending on prior year balances. I understand that to be involved in any of the Winter/Spring Programs I will be responsible for separate pledge amounts.

I / (We) understand that I and parents must also volunteer to work at our fundraising shows and/or other volunteer support events of the Tiger Regiment Band program.
